

ONLINE PRIVACY POLICY AGREEMENT

- Maintain, safeguard and/or preserve all the rights and/or property of the Northern California Packet Association; and
- Perform under demanding conditions in an effort to safeguard the personal safety of users of ncpa.ampr.org and/or the general public.

Children Under Age of 13

The Northern California Packet Association does not knowingly collect personal identifiable information from children under the age of thirteen (13) without verifiable parental consent.
